- To impart knowledge about self-resilience.

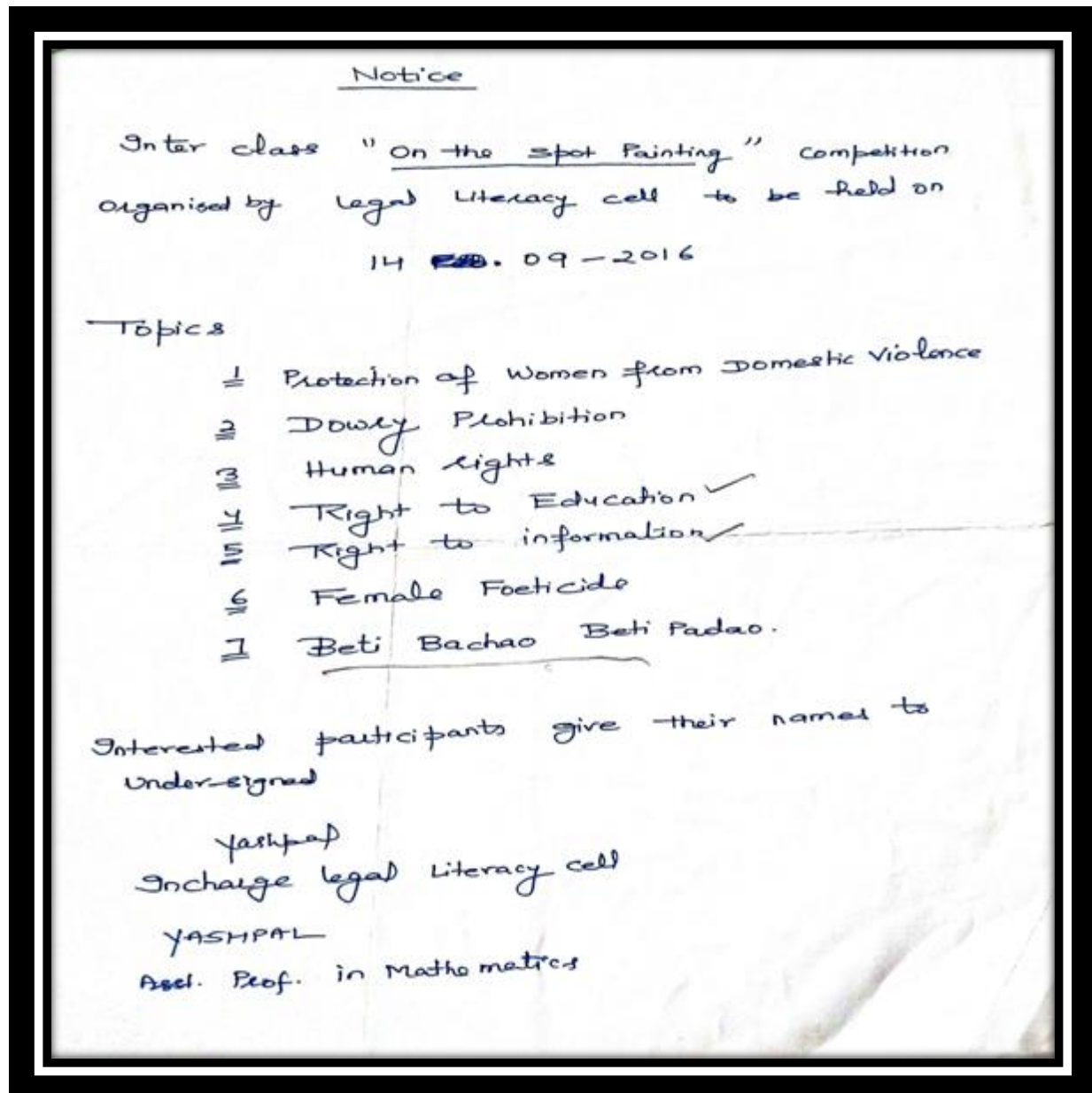

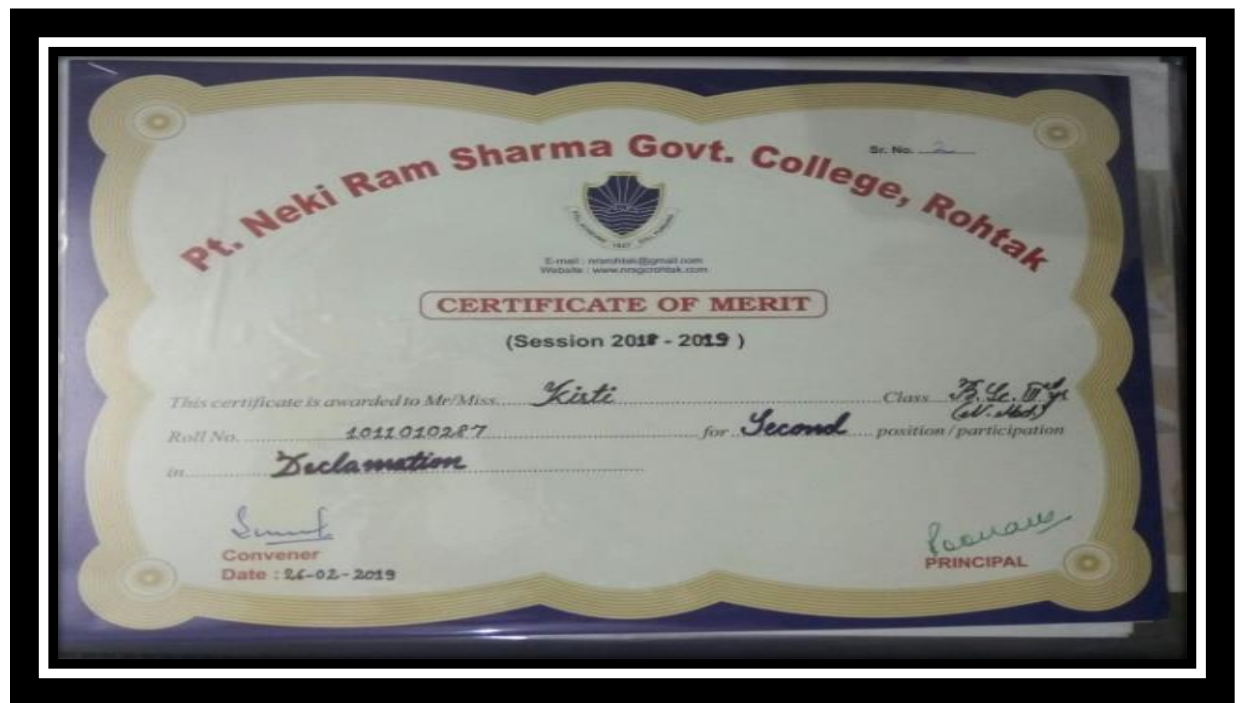
